PARTICIPANT IN Gymkhana RESERVATION ID # 7930

FOR GOOD AND VALUABLE CONSIDERATION, including permission to participate in Gymkhana and related activities, held Sun 04/22/07 - Sun 09/23/07 per Reservation ID# 7930 I, for myself, my successor, heirs, assigns, executors, and administrators;

1. Agree that prior to participating I will inspect the facilities, equipment and areas to be used, and, if I believe any of them are unsafe, I will immediately advise the person supervising the event, activity, facility, or areas;
2. Acknowledge that I fully understand that my participation may involve risk of serious injury or death, including economic losses which may result not only from my own actions, inaction's, or negligence, but also from the actions, inaction's or negligence of others, the condition of the facilities, equipment or areas where the event or activity is being conducted, the rules of play, or this type of event or activity.
3. Assume any and all risks of personal injuries to myself, including medical or hospital bills, permanent or partial disability, death, and damage to my property, caused by or arising from my participation in this event or activity;
4. Covenant not to sue or present any claim for personal injury, property damage, or wrongful death against COPPER COWBOYS, PERMITTEE/SPONSOR, OR **JEFFERSON COUNTY OR THE JEFFERSON COUNTY FAIRGROUNDS (the "COUNTY")**, their officials, board members, agents or employees, attributable to my participation in the event or activity.
5. Release, waive, discharge and relinquish COPPER COWBOYS, PERMITTEE/SPONSOR, **THE COUNTY**, its officials, board members, employees and agents from any liability, loss, damage, claim, demand or cause of action against them arising from or attributable to my participation in the event or activity, whether same shall arise by their negligence or otherwise
6. Agree that photographs, pictures, slides, movies, or videos of me may be taken in connection with my participation in this event or activity without compensation from COPPER COWBOYS, PERMITTEE/SPONSOR, **THE COUNTY**, and consent to the use of these photographs, pictures, slides, movies or videos for any legal purpose;
7. Warrant that I am eighteen (18) years of age or older, in good health and have no physical condition that would prevent me from participating in this event or activity;
8. Acknowledge that COPPER COWBOYS, PERMITTEE/SPONSOR AND **THE COUNTY** are not joint sponsors, joint ventures, partners, or otherwise jointly engaged in the above-named event or activity.
